BASIC CLAUSE PROGRAMS

THE PRICES

COMMISSION FEE

Destination partner will approve commission fee to travel agencies from 7% to 10% (for travel packages up to five nights) and 12% for travel packages more than five nights. All conditions about commission fee will be described on each program package separately.

RESERVATIONS AND CHANGES TO EXISTING RESERVATIONS

Destination partner's programs shown to travel agency agencies and accepted by travel agencies to existing reservations must be done trough destination partner Spa travel and service Vrnjačka Banja. No member will be walked to another hotel.

TRAVEL AGENCY REPRESENTATIVE

Travel agency should to have representative of the group who will mediate between group and hotels management (and destination partner). All problems must be solved immediately not after the endings of services. In a case of individual reservation all guests will get cell number of our representative of Spa travel for any question or remark;

PAYMENT TERMS
